One, or more, annual Foundation Tuition Scholarship(s), of approximately \$1,000.00, has been endowed by the graduates of Alpha Omega Colony/Chapter and will be awarded annually, as an Undergraduate Scholarship or Graduate Fellowship, to a Brother of Alpha Omega Colony/Chapter of The Fraternity of Phi Gamma Delta who has demonstrated distinguished scholarship, capacity for leadership and good citizenship (as indicated by community, college and fraternal service).

AWARD REGULATIONS

- 1) All applicants must be duly initiated or affiliated members of Alpha Omega Chapter of The Fraternity of Phi Gamma Delta.
- 2) Applicants must be in **good standing** (financial and otherwise) with Alpha Omega Chapter, The Fraternity of Phi Gamma Delta, The Alpha Omega Graduate Association and Ohio University.
- 3) Undergraduate Scholarship applicants must be a sophomore, junior or senior during the school year for which the scholarship is awarded.
- 4) Graduate Fellowship applicants must have received a Bachelor's Degree from Ohio University and be accepted or enrolled in a graduate degree program, at an accredited university, during the school year for which the Fellowship is awarded.
- 5) All applicants must be full-time students and have earned a **minimum accumulative grade point average of 3.000**, or better.
- 6) Applicants must live in the Chapter House during the school year for which the scholarship is awarded, or have previously lived in the Chapter House for, at least, **two** full school years.
- 7) Acceptance of a Tuition Scholarship or Fellowship awarded by the Foundation imposes an obligation to begin and complete a year of full-time study.
- 8) Tuition Scholarships and Fellowships will be paid to the applicant.
- 9) Completed applications (including Official Transcripts, Cover Letter and one Letter of Recommendation) must be received no later than **June 30th**.

APPLICATION REQUIREMENTS

- 1) The application must be completed, in full, and either typewritten or clearly hand written. Please DO NOT ANSWER questions with “see attached”; your application will be disqualified.
- 2) Completed applications should be postmarked or e-mailed no later than midnight **June 30th**. Late applications or partially completed applications cannot be considered.
- 3) Completed applications **MUST** contain the following items, which should be obtained by the applicant and included with the application in **One Package**.
 - a) Official University Transcripts (including Winter Grades) from all undergraduate and graduate institutions attended. (You may attach your Winter Grade Report Card to the outside of your official transcripts if the university does not record Winter Grades on the transcripts in time for the May 31st application deadline).
 - b) A Cover Letter stating your career objective, background and an explanation regarding your financial need. Note: Please attach this letter to the front of the application.
 - c) One Letter of Recommendation. This letter should be from: 1) a faculty member in your college or university; or, 2) an administrative official in your college or university. It should NOT be from the PL, or any Graduate or Undergraduate Member of the Fraternity.
 - d) Signature or e-mail verification of the Chapter Treasurer, certifying you are in good financial standing with the Chapter and International Fraternity
 - e) Signature or e-mail verification of the Chapter President, certifying you are in good disciplinary standing with the Chapter, International Fraternity and Ohio University.
 - f) Applicants for Graduate Fellowship must include a letter of acceptance or proof of enrollment in a graduate degree program at an accredited graduate school no later than August 1st.
